

This Indenture made this nineteenth day of February
 In the year of our Lord one thousand eight hundred and twenty
 between Michael M. Bayjian of the Town of Windham in the
 County of Green and State of New York of the first part and Clark
 Swin of the same place of the second part Witnesseth that the said
 Michael M. Bayjian for and in consideration of the sum of six hundred
 dollars that is to say the said Clark Swin at the instant and request
 of the said Michael Bayjian hath become bail in the aforesaid sum
 with and for the said Michael M. Bayjian to Eli Booth and David
 Weller select Men of the Town of Roxbury in the State of Connecticut
 for the maintenance of Anna Bayjian during her natural life that
~~she shall be well and comfortably supported by the said Michael M. Bayjian~~
 Bayjian and that she shall never more become chargeable or be any
 expense hereafter to the Town of Roxbury aforesaid which said all done
 before the making and delivery of these presents have granted bargained
 and sold and by these presents do grant bargain and sell unto the
 said Clark Swin his heirs Executors administrators and assigns two cows
 of Gattle four Cows, one Horse twenty two Sheep and all his Household
 furniture consisting of Beds and bedding and all other articles of House
 hold furniture and all his farming utensils all of which said pro
 perty he now in the House and on the farm now live on to have and
 to hold all and singular the said Cows Horses and Household
 furniture and farming utensils as aforesaid mentioned or
 intended to be mentioned to the said Clark Swin his Executors
 administrators and assigns forever and the said Michael M.
 Bayjian for himself his heirs Executors and administrators all and
 singular the said Goods and Chattels unto the said Clark Swin
 wife warrant and defend forever by these presents provided all
 ways made it hereby agreed between the said Michael M. Bayjian
 and the said Clark Swin that if the said Michael M. Bayjian
 his heirs Executors administrators or either of them shall well and
 truly support the said Anna Bayjian during her natural life that
 the said Clark Swin have no trouble or expense respecting his being
 bound for and with the said Michael M. Bayjian to the said Eli
 Booth and David Weller selectmen as aforesaid and save the
 said Clark Swin harmless from any expense or trouble in amount
 of the said bond during the natural life of the said Anna
 Bayjian when all this is accomplished with until the death of
 the said Anna then these presents and every Clause article
 Condition and thing herein contained shall be void and be void
 otherwise to remain in full force and virtue the said property
 has been deeded by the said Michael M. Bayjian to the said Clark
 Swin but it is further agreed between them that the said property
 remain in the name and possession of the said Michael M. Bayjian dur
 ing said term of the life of the said Anna in witness whereof the said
 party of the first part have hereunto set their hands and seal the
 and year above written
