and my Body to the Earth to be buried in Decent Christian  
manner at the Direction of my Friends who shall surround  
me

In the second place as touching my worldly interest  
my will is that my Funeral Charges and all my just Debts  
be paid out of my Estate

In the third place I give and bequeath to my beloved  
wife Submit Cruttenden all my Estate both Lands  
Buildings and moveable Estate whatever to her own  
Use benefit and Disposal for ever  
and I hereby constitute and appoint Lot Brenton of New Guilford  
Executor on this my last will and testament

KNOW all Men by these Presents, That we Lot Benton and Edward Elliot both of Guilford in the County of New Haven & State of Connecticut are holden and stand firmly bound and obliged unto Edward Russell Esq. Judge of the Court of Probate for the District of Guilford in the penal Sum of one Hundred Pounds Lawfull money of said State: To be paid to the said Judge, or to his certain Attorney or Successors in the said office - To the which Payment well and truly to be made and done, we the said Lot Benton and Edward Elliot do bind ourselves, and each of us, our Heirs, Executors and Administrators, and each and every of them for, and in the Whole, firmly by these Presents. Signed with our Hands, and sealed with our Seals. Dated at Guilford the 20th Day of October Annoque Domini, One Thousand seven Hundred and ninety four

**T**HE CONDITION OF THIS OBLIGATION IS SUCH, That if the above Bounden Lot Benton appointed Executor of the last Will and Testament of Full Britton late of said Guilford deceased; which last Will and Testament was this Day presented to said Judge, by said Executor and is by said Judge proved and approved; and said Executor has accepted and undertaken the Trust of executing said Will, and duly qualified accordingly: Now, therefore, if the said Lot Benton shall make, or cause to be made, a true and perfect Inventory of all and singular the Goods, Chattles, Credits and Estate of said Deceased, which have, or shall come to the Hands, Possession, or Knowledge of the said Executor or into the Hands or Possession of any other Person or Persons for him and the same so made do exhibit, or cause to be exhibited, into the Registry of said Court of Probate for the District aforesaid, at or before the 3<sup>d</sup> mon Day of December next ensuing: And the said Goods, Chattles, Credits and Estate; and all other Goods, Chattles, Credits and Estate of the said Deceased, at the Time of his Death, and disposed by said last Will and Testament which shall at any Time come into the Hands or Possession of said Executor or into the Hands or Possession of any other Person or Persons for him shall and do well and truly administer, and faithfully discharge the Duty and Office of Executor of the said last Will, and duly execute the same, settle the said Estate of said Deceased according to the Provisions of the said Will, the Orders of said Court of Probate and the Rules of Law; and shall settle all Accounts thereof with said Judge, within such Time as he shall limit and appoint; Then, and on such Performance, this Obligation shall be void, and of no Effect; but on Default, to be and remain in full Force and Virtue: Done in Court.

Six months is allowed from this date for the Executor
