Rewalt: Bi-Centennial Patriot

Did you know there are many descendants of a Revolutionary soldier who took part in the battles of Bunker Hill, White Plains, Trenton and was near Yorktown at Cornwallis surrender?

Some of the descendants of Capt. John Rewalt, (1755-1822) living in Yates county are the William Aspell family of Milo Center, Catherine Aspell Spencer and her sister, Mary Sumner, the Philip Ogden family, and descendants of the Depew, Legg, **Owens and Hollowell families.**

Capt. John Rewalt was born in Pennsylvania May 15, 1755 and died in Yates county Feb. 16, 1822, burried in Lakeview cemetery. He married in Lebanon, Pa., Ann McMahon Mar. 19, 1778, also buried in same cemetery. On the tombstones evidently erected by family is the inscription: the GENERAL JOHN RAWALT, Died Feb. 16, 1821 in the 66th. year of His of Milo Center, they had four children, age. On the U.S. Gov't Bronze marker she married Luther Spooner, and had is the inscription: JOHN S. Capt. John Rewalt enlisted at Lebanon, Pa, in 1775 and served in Col. Thompson's Battalion of Riflemen arched to Boston and took part in the battle of Bunker Hill. Rawalt, Died Feb. 28, 1848, Aged 89 DePuis are eligible for the Huguenot society; Peter Rawalt married Ann Hollowell and their daughter Mary J. married John C. Clark of Milo, Eleanor Clark married Henry A. Ansley, son of William Ansley who lived in Potter in the 1860's. They had three children namely Albert, Ellen and William Ansley.

After Peter Rawalt died, Ann married John Havens of Bradford, and they had a son, George Havens.

The British evacuated Boston in March 1776, and then Gen. Washington ordered five regiments to march to New York including Pa. and Va. riflemen. The Declaration , of Independence was issued July 4, 1776, and John served six months in 1776-as sergeant, and Oct. 17, 1776, he was a first lieut. Rewalt was in Northumberland Co., Pa. in 1790. He was living in the town of Benton in 1810 with his wife and five boys and two girls. In 1818 Capt. Rawalt went to Geneva, to file his Revolutionary claim, taking all the necessary papers, discharge and commission papers. They were delivered to Aaron Remer to forward to proper authorities, but he lost the papers. In December 1820/21 he made a statement and turned his papers he had left to Mr. Phelps, surrogate of Ontario county, who later moved to Illinois without any action taken. As he died in 1821/22 his family were never able to recover the papers. His widow Ann McMahon received a pension of \$480 per annum in 1839, she lived near the families of her daughters, Mary Alford Lawrence, Elizabeth Legg and Hannah Depew.

The only personal belonging of John Rewalt known to have been preserved is a Colt Revolver, No. 110,783, made in 1678, which was given to John Jr., then Jonas, and then to Benjamin Rawalt, who passed it to his son Charles T. Rawalt of Colorado, and then to his grandson, Vern Parks, Rawalt, Jr. of Chadron, Neb.

Here we have the story of a soldier who saw service during Boston, White Plains, Long Island, and Yorktown. Castle Dains, also a soldier and pensioner who was a mechanic assigned to repair the wagons, affirmed that he saw John Rawalt at White Plains, serving as a wagonmaster and that army crossed over into New Jersey. Probably, Castle Dains and John had many interesting talks after the war as they both lived in the town of Milo.
