Extracts from Regulations of Calvary Cemetery

- 1. No funeral will be admitted into the cemetery except upon presentation of a permit issued from the cemetery office, and to secure this permit a certificate must be obtained from the parish priest of the deceased person.
- No snrubs, trees, or plants of any kind will be allowed on lots with lawns, except where considered advisable as general planting by the superintendent.
- 3. Lot owners will be entitled to bury only members of their family in lots owned by them. Although the cemetery is intended primarily for the burial of members of the Catholic Church, nevertheless, in the case of mixed marriages, where the non-Catholic party has died outside the Church, the Church, not wishing to separate in death those who were united in life, permits the non-Catholic relatives to be buried in the same lot with the Catholic relatives, provided that no religious ceremony be held at the grave.
- 4. To avoid any misunderstanding, owners of lots or single graves are requested to consult with the superintendent before buying markers, monuments, or contracting for vaults, and ascertain the dimensions required, etc.
- 5. Before making improvements, this lease must be produced by the lot owner, and a written permit obtained for such improvements from the cemetery authorities.
- (a) On family lots only one monument is allowed.
 (b) Markers not to exceed 2x1 in size, to be placed on a level with the surrounding ground, will
- be permitted over graves in family lots.

 (c) No monument shall have ornaments unbecoming a sacred place. The inscriptions "Pray for me," "Pray for the souls of the faithful departed" or "May his (or her) soul rest in peace" are much recommended.
- (d) No monument without a cross will be allowed in the cemetery.

Regulations for the size of base stones are as follows:

- (e) Monuments on single graves must not exceed 2 feet high above ground, 2 feet wide, and not more than 1 foot 6 inches in depth.
- (f) The base stone of monuments on two-grave lots must not exceed four and a half feet square of surface, and not more than three feet in width.
- (g) In lots 10x10 or 10x12, the base stones are not to exceed 6¼ square feet of surface and not

more than 2 feet 6 inches in depth. In lots 10x20, the base stones are not to exceed 30¼ square feet of surface, and not more than 5 feet 6 inches in depth. In lots 20x20, the base stones are not to exceed 6 feet in depth and not more than 8 feet in winth.

- (h) For monuments, vaults, etc., we recommend the use of a good quality of granite, in preference to marble, on account of being more durable and less liable to damage by the elements.
- (i) The monuments in lots 10x20 or more shall be erected in the center of the lot. In order not to mar the general aspect of the cemetery and the monuments on other lots, all vaults above ground shall be erected only in locations selected by the superintendent, and shall be subject to restrictions in regard to surface covered, the same as applied to monuments.
- (j) No improvement of any kind shall be made on any lot before the lot has been paid for in full.
- 6. It is hereby expressly stipulated that no improvement in wood or iron shall be made on this lot, and that the filling and care of this lot shall be done by the superintendent of the cemetery.
- 7. The plans and contracts for all intended monuments or other improvements shall be subject to the approval of the Bishop.
- 8. The Bishop reserves the right to refuse permission for the erection of improper improvements, or the use of the cemetery to persons who may make themselves obnoxious.
- 9. There shall be no vault above ground made of cement or concrete, but must be of granite or marble; and no coping around graves or lots will be allowed. Underground vaults are not permitted on lots of less than 400 square feet.
- 10. Excavating and concrete work shall be done by the cemetery employes—and all work is guaranteed.
- 11. No sale, assignment or transfer of any right of burial in any lot in Calvary Cemetery will be permitted without the written consent of the owner of the cemetery; and no such sale, assignment or transfer will be valid until recorded in the office of the cemetery.

These rules are subject to change without notice.
