ORDER SETTLING FINAL ACCOUNT AND
FOR DISTRIBUTION

The final account, report, and petition for distribution herein of Jerome S. Reider, as administrator of said estate, by Paul F. Mattoon, his attorney, coming on regularly this 9th day of February, 1939, for hearing and settlement by the Court, notice thereof having been duly given, as required by law; and no person appearing to except to or contest said account, report, or petition, the Court, after hearing the evidence, and finding said estate is separate property and no income nor inheritance tax due herein, settles said account, approves the report, and orders distribution of said estate as follows:

It is Ordered, Adjudged and Decreed by the Court that due notice to the creditors of said deceased has been given; that the said administrator has in his possession, belonging to said estate, after deducting the credits to which he is entitled, a balance of \$142.00, consisting of cash, and that said account and report be allowed, approved and settled accordingly; that there be allowed to said administrator, statutory commissions in the sum of \$30.00, and extra fees in the sum of \$70.00, and that there be allowed to said attorney, statutory fees in the sum of \$30.00, and extra fees in the sum of \$70.00, as set forth in said account; that said deceased left surviving as her only heirs-at-law: Therone Griffin, husband, Jerome S. Reider, brother, Joseph A. Reider, brother, William A. Reider, brother, and John Jerome Reider and Mary Louise Reider, children of John Reider, deceased brother of decedent; and by virtue of an assignment and deed dated March 30, 1938, recorded in Book 15708, Pages 62 and 63 of Official Records of the County of Los Angeles, State of California, the said cash, and all other property belonging to said estate, whether described herein or not, be distributed as follows:

To Therone Griffin, husband of decedent, 8/16th thereof, or \$71.00;
To Jerome S. Reider, brother of decedent, 6/16th thereof, or \$53.25;
To John Jerome Reider and Mary Louise Reider, heirs of John Reider, deceased brother of decedent, 1/16th each, or \$17.75 in equal shares.
