- 2 ORIGINAL BUREAU OF VITAL STA-TISTICS CERTIFICATE ALSO COMPLETE AND FILE WITH RECORDER. WITHIN THREE DAYS AFTER THE CEREMONY. DO NOT FILL OUT COPY OF SAME ON THIS PAGE.
- 3. ENGRAVED CERTIFICATE ATTACHED BELOW FILL OUT. CERTIFY AS INDICATED, DETACH AND HAND TO PARTIES JOINED IN MARRIAGE.
